

The Coronavirus Aid, Relief, and Economic Security (CARES) Act, the Coronavirus Response and Relief Supplemental Appropriations Act (CRRSAA) 2021, and the American Rescue Plan (ARP) Act granted funds to institutions through the Higher Education Relief Fund (HEERF). Institutions must use a percentage of these funds to provide emergency grants to students for any component of the cost of attendance or expenses related to the disruption of campus operations due to the Coronavirus pandemic. Eligible expenses include housing, food, technology, course-related, medical, and child-care.

Shawnee State University signed and submitted the Certification and Agreement Form for the CARES funds on April 20, 2020.

Shawnee State University received the following HEERF funding for student grants.

CARES Act/HEERF I

All HEERF I (CARES Act) funds were expended as of October 5, 2020.

An online application opened on Monday, May 11, 2020. The application deadline is Sunday, May 31, 2020. A review of applications will take place after the deadline.

Students (2612) who met the following eligibility criteria received an email notification.

- Filed a FAFSA for the 2019-2020 or 2020-2021 academic year
- Have been enrolled on March 31, 2020 at SSU for the spring 2020 semester as an undergraduate or graduate degree-seeking student
- Not enrolled as an e-campus program (no face-to-face classes) for the spring 2020 semester
- Have a valid social security number
- Be a U.S. citizen or eligible non-citizen
- If male, be registered for selective service
- Have a high school diploma, GED, or completed high school in an approved homeschool setting
- Making satisfactory academic progress
- Not in default on a federal student loan

I'm happy to announce that the application for Shawnee CARES Grants will be available on Monday, May 11 for students currently enrolled in spring semester.

These grants are intended to help defray certain expenses related to the disruption of campus operations due to the coronavirus pandemic. Shawnee CARES grants are funded by the federal Coronavirus Aid Relief and Economic Security (CARES) Act and will be awarded on a first-come, first-served basis while funds are available. Application requests will be considered up to a maximum of \$1,200, however, the full amount of a request cannot be guaranteed.

The Coronavirus Response and Relief Supplemental Appropriations Act (CRRSAA) 2021 was awarded to 2578 eligible students who attended spring semester 2021. SSU awarded funds based on the student's Expected Family Contribution (EFC) as outlined below.

A: HEERF funds will be issued using the refund preference you designated through BankMobile. If you have not selected a refund preference, I would encourage you to do so by Tuesday, May 4. You can visit the BankMobile site by logging into your MySSU account, clicking on the Student tab, selecting Billing Information on the menu on the left, and selecting the BankMobile link.

Q: Do I have to complete an application?

A: There is no additional application required to receive HEERF Funds.

ARP/HEERF III

An online application opened on Friday, October 22, 2021. The application deadline was November 15, 2021. An ongoing review of applications began on October 25, 2021.

Emails were sent to 2585 eligible students encouraging them to apply for the funds. Copies of the emails sent are below.
