This training will address the proper procedures for entering and working in a Confined Space as set forth in OSHA General Industry Regulation, 29 CFR 1910.146. All employees who must work in and near confined spaces and managers and supervisors who need to understand confined space requirements imposed by OSHA should take this 7 hour training. All instructional materials will be provided.

In this training, the student will:

- Identify, classify and control confined spaces and permit required confined spaces;
- Use and maintenance of full body harnesses, tripods, retrieval devices and other PPE;
- Correct methods for air monitoring and ventilation;
- Identify the responsibilities of authorized entrants, attendants and supervisors.

Registration Fee: \$195 (\$139 for Southern Ohio Safety Council members).
