Shawnee State University's Evaluation of General Education Transfer Courses

For Shawnee State University (SSU) to evaluate whether a General Education course should be accepted for transfer credit, the following questions should all be considered:

- If it is a course coming from an Ohio public institution, is the course <u>approved for Ohio Transfer</u> <u>36</u> (OT36)?
 - If it is an online natural science lab course, is the online version of the course approved for OT36?
- If it is a course not coming from an Ohio public institution, does the course align to the OT36 learning outcomes and requirements?
- Is the course a General Education course at the transferring institution?
 - Do the General Education learning outcomes at the transferring institution <u>align to</u> <u>SSU's</u>?
- If there is an equivalent course at SSU, does the course content broadly align (>70%) to SSU's course?

The respective Department Chairperson and the Director of the General Education Program (GEP) will weigh these questions in making their decision whether to award the course General Education credit.

Transferred courses may be awarded direct equivalencies to current SSU courses, assigned to an Advising Requirement Code (ARC) if there isn't a direct equivalency, or not awarded General Education credit.

The Department Chairperson and Director of the GEP may request syllabi for any transfer courses to help evaluate their applicability for General Education transfer.

Special Notes:

Online courses should be treated as equivalent to in-person courses per OATN policy.

In the case of online natural science labs for most cases if the online lab course is accepted for credit, it will not be made equivalent to an existing SSU course, unless the existing SSU course also is online. Most courses will be aligned to the appropriate ARC.

In the case of transferred fine arts courses, general education courses cannot be based in skill development (e.g. music lessons, studio arts, theater, etc.).

In the case of transferred foreign language courses, general education courses must be primarily devoted to literature and not focused on grammar nor be skills based.

Appeal Process:

If an involved party is unsatisfied with the decision based on the review of the courses they can follow the appeal process outlined in <u>University Policy 2.19</u> and its associated procedures.

ARC's should be used to award a transfer course General Education credit at SSU when there is no equivalent SSU course.
